



How to invest? - Account opening process






Foreign Investors need three things to trade in Vietnam stock market:

- **Securities trading code** (STC): 7-10 days, standard documents, notarized copies.
- *Indirect Investment Capital Account* (IICA): 3-4 days but requirement is high (e.g. KYC, anti-money laundering). Some banks require physical presence at the bank.
- *Trading account*: simple process: 01 day.



What are the obstacles?






IICA opening process is painful because:

- Only some banks provide the service.
- Know your customer (KYC) is strict: customers are required physical presence at the bank to open the account => customer has to travel to Vietnam.
- Money transfer and currency exchange are also the problems if the customer does not stay in Vietnam => take time & costly to transfer fund.
- Some banks require physical presence to transfer money back to your country.

VNDIRECT's solution






- Your company opens an account and become VNDIRECT's partner.
- Using omnibus account to allow your clients to trade directly.

VNDIRECT's solution


